Squash/ Tennis DEED: David Dent, the past Vice President, spoke to the meeting about the negotiations which have thus far taken place between Squash and Tennis.

It has been agreed that instead of Tennis making a lump sum monthly payment to Squash to cover our obligation for Pavilion costs, we now have almost completed

an agreement, whereby Tennis will now pay, at an agreed percentage, for services, eg: gas, insurance, cleaning etc. as invoiced by Squash when our portion is due.

This DEED also replaces the last known Deed of 1985 and all other Deeds, detailing the relationship of ownership, responsibilities and access that each club enjoys in our partnership.

The meeting gave approval to David Dent and Les Wright to sign off this DEED on behalf of the Club.

Audit Phil Lendrum spoke to the meeting about the requirements of Audit and discussion was held as to whether a Club of our size needs such a detailed process and its costs.
